

# All in for Health Equity Goals

- Build authentic collaborations across sectors of society.
- Co-create an aligned agenda and an initiative intended to make a significant impact on health justice.
- Informed by national public polling, focus groups, and the Multisector Partner Group deliberations.



# **Multisector Partner Group**

- 8-10 representatives from a range of sectors.
- Will inform and guide the Center for Health Justice's programmatic and partnership building activities.

### Member expectations:

- Bring your authentic self to all activities and work.
- Actively participate in all meetings.
- Complete all pre- and post-meeting work.
- Time commitment will be 3-5 hours/month for 3 years.



# **Application Process and Requirements**

The Center for Health Justice launched the Call for Nominations for the Multisector Partner Group on January 11, 2022, and we are now accepting applications.

- Applicants can only apply online. You must have an account with CadmiumCD to apply.
   New Users should create an account.
- Applicants can either apply as an individual or as an organization.
- Deadline to apply: February 18, 2022.

#### **Components of the Application**

- Applicant Type
- Personal Information
- Application Questions
- Supporting Documentation



## **Review and Selection Process**

A selection committee of AAMC staff will review all complete applications after the application closes.

#### **Criteria for Applicants**

- Align with the AAMC Center for Health Justice's goal to make a significant impact on health equity.
- Demonstrate relevant health equity activities.
- Display interest in being a member of the Multisector Partner Group.
- Ability to disseminate information to the public and describe the engagement of target audience.



# **Key Dates and Deadlines**

Application Opened	January 11, 2022
Application Closes	February 18, 2022
Applicants Notified	March 1, 2022



# **Multisector Partner Group Meetings**

After selected members of the Multisector Partner Group are notified, they will participate in a series of six virtual collaborating meetings:

April 11, 2022	May 23, 2022
April 25, 2022	June 6, 2022
May 9, 2022	June 21, 2022
