

Methodology

This poll was conducted between October 18, 2023, and October 27, 2023, among a sample of 6,748 U.S. adults. The interviews were conducted online, and the data were weighted to approximate a target sample of adults based on age, gender, race, educational attainment, region, gender by age, and race by educational attainment. Results from the full survey have a margin of error of plus or minus 1 percentage point.
